Also, Mr. Brown mentioned to the Board that a Co-op meeting with both Maywood and Hayes Center should be scheduled this summer.

Mrs. Huff presented the superintendent report. Mrs. Huff talked to the Board about summer maintenance projects. The old bleachers will be taken out, the gym floor re-done, and the new bleachers put in during the month of June. Mrs. Huff also mentioned that some of the projectors in the classrooms are needing replaced. The administration decided to replace 3 projectors per year until all projectors all been replaced

and updated. Siding and roof repair for the modular building will also be completed this summer. The classified staff plans on working 4 days per week, 10 hours per day throughout the summer. Mrs. Huff also presented the Board with a superintendent evaluation tool that the Board will complete.

Ms. Armstrong presented information on the Maywood Agriculture Education Program. She shared her goals for the FFA department and asked the Board for ideas or changes if needed.
