5. Reports

- 5.1 Board Reports-The Board spoke of the idea of a survey for staff to complete for board members, principal and superintendent. The Civics Committee reported to the Board the meeting they had with Mr. Hamilton and Mrs. Bauer about the Nebraska Sate Social Studies Standards. They discussed the new bill from the legislature and the new requirements.
- 5.2 Principal Report- Mr. McCain spoke to the Board about the Multi-Cultural reporting done by teachers. He also mentioned the Wellness committee, and free and reduced lunches. He also gave an update on Parent-Teacher Conferences. High School parents had approximately 78% turnout and elementary was 90%. Our school participated in a triad day for all of our teachers on Friday, October 11, 2019 at Wauneta-Palisade with Hayes Center schools also. Our schools AQuESTT rating for both high school and elementary was recently released. Overall our school is rated as great with high school being rated as good and the elementary as excellent.
- 5.3 Superintendent Report- Mr. Brown spoke to the Board about the Crisis Team and Safety Team protocols for our school. He also explained to the Board that we had a school wide safety day on October 4th. All drills were practiced by kids, staff and employees. Mr. Brown went to the law update in September and told the Board some issues discussed were FERPA and vaping (JUULING). Mr. Brown explained that these topics are becoming issues in our school as well. The representative from Ameresco plans on having sub-contractors come to look at possibilities for HVAC, lighting and windows. Midwest Roofing began the roofing project last week. The Steering Committee plans to meet to prepare for the external visit, The negotiation team will begin negotiations with the Board soon.
- 5.4 A.D. Report- Mr. Brown reported for Mr. Hamilton. Fall sports are winding down. Cross Country Boys placed 2nd at RPAC cross country meet. Volleyball RPAC will begin next week, Maywood will be hosting games on Monday. Football is currently 4-2 and hopefully looking to qualify for playoffs. The COOP agreement between Maywood and Hayes Center was renewed with NSAA for 2 more years. The COOP committee will need to meet with coaches to discuss declaring 6 or 8 man football.
